



## Notification of pregnancy or breastfeeding

*According to § 15 and § 1 para. 2 no. 8 MuSchG (Maternity Protection Act), a student should inform the university of the existence of a pregnancy and the date of delivery as soon as she knows that she is pregnant. A breastfeeding student should inform the university immediately that she is breastfeeding. Students can only invoke the protective provisions of the MuSchG if they have notified the university that they are pregnant or breastfeeding. In accordance with Section 27 MuSchG, the University of Hohenheim must notify the supervisory authority (Regierungspräsidium Stuttgart).*

Information on data protection
